

RESOLUTION #619
Banner Permits
Borough of Kulpmont

WHEREAS, The Borough of Kulpmont obtains banner permits for the erection of banners across state Highway's located within the Borough; and

WHEREAS, The Borough of Kulpmont desires to pass this resolution, which includes all banners, erected in the Borough of Kulpmont on yearly basis; and

NOW, THEREFORE BE IT RESOLVED, That the Borough of Kulpmont, County of Northumberland, does herewith Provide the following information as required by the Pennsylvania Department of Transportation for all the following banner permits to be erected annually as stated, with the Borough of Kulpmont:

1. *The locations will be as follows:
Rt. 61 – Chestnut Street – 5th & Chestnut Streets & Chestnut & 14th Streets
Rt. 61 – Chestnut Street – 8th & Chestnut Streets*
2. *Vertical ground clearance will be at a minimum of 17'6"*
3. *The size of the plastic banners will be 2' wide by 10' long.*
4. *Event, Description of Message, Installation and Removal Dates:*
 - A. *Annual Kulpmont Car Cruise August 21, 2005, 2nd week in August until the 4th week in August 2005.*
 - B. *East End Fire Company #1 Annual Picnic August 12, & 13, 2005, week of July 25, 2005 until the week of August 15, 2005.*
 - C. *Kulpmont Borough Fire Department – Fire Prevention Week beginning October 3, until October 8, 2005, week of September 26, 2005 until week of October 10, 2005.*
5. *Commercial Advertising will be no more than twenty percent (20%) of the message.*
6. *Temporary cables will be used in the erection of the banners.*
7. *Traffic Control for erecting and removing the banner will be in accordance with the most current PENNDOT Publication for Work Zone Traffic Control.*
8. *The Borough of Kulpmont Assumes the Responsibility for erecting, maintaining, and removing the banners.*
9. *The Borough agrees to Indemnify and Hold Harmless the Pennsylvania Department of Transportation and Department Employees from liability for damages or injury to any persons or property associated with the placement of banners.*
10. *The Borough Authorizes the following herewith identified Nicholas P. Goretski, III, Council President, and Frank Chesney – Borough Secretary, to execute any and all documents as may be required by the Pennsylvania Department of Transportation.*
